Important Note: Pilots are responsible for making sure that they have a current FAI Sporting Licence that is valid for the whole competition.

Insurance

Documentary proof of personal insurance for pilots must be presented to the organisers at registration. It shall comprise:

- A valid insurance certificate, *in English*, covering public liability risk. (N/A for UK pilots as above)
- A Personal accident/hospitalisation/repatriation to home country insurance (N/A for UK pilots as above):

Third party liability limit: 1 million Euros

Medical care limit: 1 million Euros

Repatriation limit: 1 million Euros

Important Note: The organisers will not be able *to provide insurance*. It is therefore *essential* that all pilots must organise their own insurance for the competition before their arrival.

Refund policy:

In the event of a pilot withdrawing from the competition before *13th September 2026* a full refund will be offered. Cancellations received after this date will get a 50% refund.

If the competition is postponed to the alternative date and a pilot cannot attend that weekend then a refund will be given minus an admin fee of £20.

SCORING

Method – as per Section 7C

The target radius is 10.00metre

- Falls will be scored to 10.00 metre
- The pilots constituting a team are chosen at the latest before the first competition round. Once chosen, pilots cannot be replaced for any reason.
- A team score for each round shall be the aggregate score of all the pilots in the team.

Flying order – Team order drawn. All number 1s fly in order followed by number 2s then number 3s.

Video evidence - Yes. (Mandatory as per Section 7C 3.6) Amateur video evidence will be accepted.

AMDs used: Weckbecker

Launch interval: as per Section 7C

Number of rounds and number of minimum rounds: Maximum 12 rounds, minimum two rounds.

WIND LIMITATIONS

~~The maximum permitted wind speed at take-off will be 8m/s.~~

The maximum permitted wind speed at take-off if alternative date (airfield take-off) used will be 7m/s.

The maximum permitted wind speed as measured at the target during the final 30 seconds of a competitor's flight will be 7m/s. These wind limits can be reduced for safety reasons by agreement with pilots.

EQUIPMENT REQUIREMENTS

All equipment must comply with FAI Sporting Code Section 7C-8.

Towing equipment – all pilots will be required to provide a tow yoke if flying at South Cerney (backup location, target field 3)

Safety Committee

The Safety Committee will be elected at the first Pilots briefing and will include 3 competition pilots from different teams.

COMPLAINTS AND PROTESTS

Refer to General Section, Common Section 7 and Section 7C.

Initial complaints will be dealt with by the Chief Judge.

The Protest fee is £50 and will be returned if the protest is upheld.

Note: Team Leaders are encouraged to read Section 7C and Section 7 Guidelines chapter 7 before making a complaint or a protest.

Protest committee composition principle:

A Protest Committee shall be constituted as soon as possible after the receipt of the protest and shall consist of a Protest Committee Chair appointed by the Meet Director (or by the Chief Judge if the protest relates to the actions of the Meet Director) and 2 representatives nominated by the competitors. The Chair of the committee shall be someone who has a good knowledge of the rules and none of the panel should have been directly involved in the original dispute, or be a team member of the competitor involved.

Additional Information

Rules for the National Championships

Objectives

The objective of the National Championships is to determine the National Team Champions and National Champion of the UK Paragliding Accuracy Competition by means of a competition open to both teams and individuals of the BHPA.

This is in addition to the objective of determining the International Team Champions and International Champion of the Open Paragliding Accuracy Competition by means of a competition open to both teams and individuals that hold a current FAI paragliding licence.

24.2 Eligibility

The National competition is open to all current members of the BHPA holding a minimum Paragliding Club Pilot rating. The International categories are open to holders of a current FAI paragliding licence.

1.3 Categories

The National Championships will comprise the following categories (in addition to the international team and individual prizes open to holders of a current FAI license):-

1.4 Eligibility for Categories

| a) Club Team | Entrants for the team trophy must be BHPA members and have been members of that BHPA registered club for at least the last 6 months. |
| b) Individual | BHPA members. |
| c) Best Female | BHPA female members. |
| d) Best Under 26 | BHPA members. |
| e) Best Veteran | BHPA member aged 60 or over, on the start date of the competition. |
| f) Most Improved Individual | BHPA member who has improved the most places compared to their best placing in any of their preceding three valid championships. In the event of a draw the |

pilot with the highest finish in the current year's championships will be the winner.

g) Best Newcomer

BHPA member who has not previously competed in this event.

h) Best Novice

BHPA member not eligible to compete in the National or Open competition categories. EP Minimum.

There must be a minimum of three entries in categories a) to g) for trophies to be awarded in that category.

Pilots who have given two weeks' notice may be allowed to fly out of sequence to bank or catch-up flights at the Meet Director's discretion subject to a credible reason. The pilot must present a credible reason due to unavoidable or prior commitments and must state the day that will be missed. Should the pilot not get a favourable decision off the Meet Director then they can appeal to the BHPA Accuracy Panel. This rule is only applicable to the National Championships. Should the pilot also be eligible for the FAI Cat 2 competition they will receive 10m scores in that element of the competition for any flights missed.

Launching

If the competition is stood down for winds being over competition limits there shall be no fun flying even if it is considered safe for some pilots to do so. Any pilot who does fun fly will get a maximum score in the next round. Fun flying will be allowed at the end of a day's flying.

Rules for the Novice competition

The Event will also include a separate competition for pilots not eligible to compete in the National or Open competition categories.

To enter use the entry form which can be downloaded from the BHPA Accuracy website.

All the above rules apply to the Novice competition unless modified below:

Objective

The objective of the novice competition is to determine the Novice Champion of the UK Paragliding Accuracy Competition by means of a competition open to individuals of the UK.

Eligibility

The Novice Competition is open to UK pilots either without a rating, or with no higher than a CP rating who are entering the novice competition for the first time since achieving CP status and have held their CP rating for no more than 24 months. Pilots with a CP rating who have previously won the Novice Competition are not eligible to enter again. All pilots entering the novice category must provide evidence at registration of rating/license, and flight numbers and hours flown as required. Competitors are encouraged to enter the category appropriate to their ability in the spirit of competition. The Eligibility is guidance only and the category for individuals will be decided by the Chief Judge and Meet Director.

Launching

Competitors must be accompanied at the launch point by their nominated instructor.

Method of scoring

Scores will be measured and recorded up to a distance of 10.00m from the edge of the disc. Scores greater than this will be recorded as 10m. At the discretion of the Chief Judge, distances beyond 10m may be measured by pacing, for the pilot's personal record of their performance. Should there be no recorded scores under 10m the competition result may be determined using paced or estimated scores, with the agreement of competitors.

Validity

The Novice Competition may be validated on a different number of completed rounds from the main competition.

External Aid

During a competition flight a pilot may only receive external communication in case of immediate safety concerns. This will be provided by a nominated instructor. The judges should be made aware of who the instructor is prior to the flight.

Wind Speed

At the discretion of the Meet Director and Chief Judge a different wind limit may be agreed for the Novice Competition. This decision will apply to all pilots in the category.
